Ugu Trussell brought up that a scholarship had been awarded to Anthony Jones on July 1st, from Tomball, who would be attending Texas Tech. Pictures would be sent in to be posted on our website, and it was hoped that our second recipient would be well enough to have her pictures also sent in July.

At Large Chief William Hoff asked permission to address his proposal regarding membership to NCAI. He had received his delegate card and talked with them several times, but as yet there was no information dealing with our Tribal status. They said they would get back in touch with us, but we have received no word thus far. Our membership in the NCAI, as a Tribe, opens possibilities to our members in terms of social interaction, learning how to deal with governmental bodies, education or work grant funds, to name a few. Ugu Ron Trussell stated that they would receive no more monies until we have an official Tribal Status with the organization.

Jack and Brenda Sheridan spoke about the project with the Governor of Texas office. With the virus and its effects on the state, scheduling to meet with Governor Abbott has been difficult. A member of the Governors' staff has reached out to us and scheduling will be arranged. We will be given at least a 2 week notification so that we can meet in the Governors' office, and do our presentations.

Deputy Chief Stephenson will teach different forms and techniques of braiding. The Woman's war drum will be set up.

Thursday, Friday, and Saturday are expected to be very full days with training, with various ceremonies, and even a corn hole tournament!

Joshua Eagle Claw Young wishes to spread the word about 2 Wolves motorcycle club Charity in the Eastern US District.

Further information on our road upgrade is that it is listed as a private road that was originally leased as a service road. We are still attempting to gather information so we can put some rock down. The trees along the roadway will have to be trimmed back to prevent damage to vehicles.
